## HALCYON HOUSE

**Halcyon House based in Formby, Merseyside** is part of the Abbeyfield Group and provides care for 31 frail and elderly residents with a variety of complex needs, including patients affected by strokes. AnnMarie Roberts has been the Matron of Halcyon House for the past 7 years and has overseen the introduction of Abylss CMS to the home.

## STANDARD SET UP

“The care team got to grips with the system really quickly” explains AnnMarie. “We run the desktop across 2 different computers and we also bought two tablets for the nurses to use day to day. We use the desktop for general management and the creation of our residents’ care plans and then complete the pre-set templates using the tablets.

The system really helps day to day as it frees up so much time for the staff. A standard review for an outside agency now takes us around 10 minutes to complete. Before we were using Abylss CMS, a review took us around 2 hours to complete because we had to photocopy everything as well as finding all the required information. The copying alone took us over an hour. Not a good use of our nurses time!”

## LOOKING AHEAD
